4 SECTION 4: First aid measures:

4.1 Description of first aid measures:

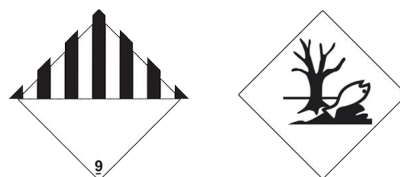
